Facility Information:

This facility operates as an animal shelter as defined under s. ATCP 16.01(3). HSWC also holds an animal control contract to house stray dogs for the City of Waupaca. HSWC consists of a single building. All enclosures are indoors. Dogs are provided access to clean water all day and are typically fed twice a day, morning/evening time frame.

Primary- There are 3-separate areas dogs may be housed in. The first room has four enclosures used to house small, adoptable dogs that provide 16.5 ft2 of floor area. This is viewable to the public from the lobby area. The main housing area has 13 enclosures that provide 24 square feet of floor area; two enclosures that provide 32 square feet of floor area.

Isolation- The isolation room has three enclosures that provide 16.6 square feet of floor area. This room can be used for multiple reasons as needed.

Exercise & Enrichment - There are six outdoor, fenced exercise areas, five are on concrete and one is grass. Shade canopies are provided during months when shade is necessary. Dogs also receive walks and obedience training with staff and volunteers.

Records- Electronic (PetPoint) and handwritten records are kept.
